9. Working together during the outreach

Everyone is part of the Reach Mallorca mission team and each team member is valuable. Even though we have staff members and leaders who have slightly more responsibility than the rest of the team,

we still need every single person to reach our goal of touching as many people as possible with God's love. Reach Mallorca's main focus is on the outreaches that take us to Ballermann and other locations, even though there is also time for fellowship and leisure activities during the day. That's why Reach Mallorca is not a holiday, but a mission outreach. This also includes self-catering in the team flats. Everyone is expected to do the shopping, cooking, tidying up, as well as be punctual and help with organising everything.

During the outreach, you'll probably also have the opportunity to get involved in the following areas: -

- **I. Street theatre:** As part of the outreach, team members may get the chance to present the gospel in a creative and personal way through sketches and mimes. You don't need any acting experience, as the parts played will have different levels of difficulty.
- **II. Worship:** Worship is an essential part of Reach Mallorca, both during our team times together and during outreaches. The different worship teams will be organised and assigned in Mallorca. You should already have experience in this area. Are you moved by the idea of leading people into God's presence? Then sign up for the worship team!
- **III. + IV. Sound technology and equipment:** As part of the technical team, you will also be working closely with the worship team. If you already have some mixing experience and are up for a new challenge, then the sound team at Reach Mallorca could be just the thing for you. We might also get the chance to set up a stage and technical equipment outside and need hands-on people who know or want to learn how to load a sprinter van properly. Every little helps!
- **V. Video projector:** For the team church meetings, we also need a video projector team to project texts and PowerPoints. No previous experience is required, as everyone will be given instructions on how to use the projector.



- VI. Street and beach sermons: The Reach Mallorca outreach also includes larger beach and street services, sometimes attended by several hundred people. If you feel confident about preaching a short and concise evangelistic message in public in front of lots of people, then you are more than welcome to get involved in this area.

An additional registration fee will be charged for these two outreaches, because a second trip has to be added. 11. Rules to follow...

We truly believe that being part of this outreach will change your life and that God wants to use you in a very special way. We will start praying for you even before the outreach begins and will try and support you in your gifts and abilities as best we can. As we want this outreach to be a really special time for you, we have put together a few rules that we feel are necessary to make your time in Mallorca a blessing for you, the rest of the team and especially for the people we want to serve. Please follow the rules below:

1. There may be times during this outreach when you disagree with decisions made by your leaders and see certain situations differently. Especially at such times, please submit to your leader's decisions and follow them. Your (small group) leader usually has a few more outreaches under his/her belt than you and has very specific reasons why he/she might sometimes decide differently to you. Besides, leaders are only human and make mistakes like everyone else. Your team functioning as a unit is more important than always making the right decisions. This especially applies to the small groups.

During the outreach, we have a rule that no-one should start a relationship with a member of the opposite sex. If you are attracted to someone, please keep it to yourself until the outreach is over and refrain from showing your feelings through your behaviour. If you are already dating, then please put your relationship on hold during the outreach, so you can completely dedicate yourself to your team. By this, we mean refraining from physical contact (holding hands, kissing, etc.) and spending time alone as a couple. The reason for this rule is that we feel it is important for everyone to stay completely focused on God during the outreach and not to awaken desires that, even though they are absolutely healthy and natural, tend to distract people from the goal of the outreach.

- 2. Drugs, alcohol and cigarettes are a no-go during the outreach.
- 3. There is nothing that can destroy the atmosphere of an outreach as much as speaking badly about other people, whether leaders or other team members. Please refrain completely from this kind of talk.

If you do not follow these rules, the outreach leadership may send you home at your own expense.



General Information and Terms and Conditions for Reach Mallorca

1. Application

By completing the application form, the applicant agrees to be part of a Christian community and to participate in the relevant programme. If the leadership sends a participant home for disciplinary reasons, the costs of the return journey will be covered by the participant or his/her parent or guardian. Participants are expected to be willing to take part in group sessions and events. During a GOSPELTRIBE outreach or other GOSPELTRIBE events, participants are expected to abstain from drug and alcohol consumption.

2. Confirmation

Unless otherwise stated, applicants will receive a written confirmation of their application with a request for payment upon receipt of their application form. Applications are not legally binding until the outreach or event fee has been fully paid.

3. Price increases

We reserve the right to transfer any significant cost increases occurring before the start of an event or outreach and add these increases to the original price.

4. Liability

GOSPELTRIBE accepts no liability for self-inflicted damage, accidents, losses, delays or other cases of damage. We are not liable to pay any compensation for cancellations due to force majeure (water, fire, storm, etc.). The participant or his/her parent or guardian grants GOSPELTRIBE e.V. permission to seek medical assistance in the form of treatment, anaesthesia and surgery in the event of an emergency, insofar as this is necessary in the opinion of the attending doctor, and exempts GOSPELTRIBE e.V., its staff and volunteers from any liability resulting from injury, damage or loss caused by or afflicted on the aforementioned person during an event/outreach.

5. Changes and amendments

We reserve the right to make any changes to the programme, for example for organisational reasons. If necessary, we will inform participants of any changes personally in writing.

Non-commercial use of photos and film recordings

The participant or the participant's parent/guardian agrees that photos and film footage may be used without restrictions for non-commercial purposes within GOSPELTRIBE, JMG and THE FOUR publications. This may include sharing the photos with other media. However, if the participant refuses his/her consent, he/she must inform GOSPELTRIBE in writing by post.



7. Cancellation and withdrawal policy

A participant may cancel at any time prior to the start of a GOSPELTRIBE event or trip. For preservation of evidence reasons, this cancellation must be made in writing and sent by post. The postmark determines the date of cancellation. If the participant withdraws from the travel contract or does not take part in the trip/event without withdrawing from the travel or event contract, any compensation for arrangements already made will be retained. The organiser may claim a lump-sum compensation. This amounts to

- 20% of the event price for a withdrawal between the 60th and 43rd day prior to the event or outreach.
- 35% of the event price for a withdrawal between the 43rd and 22nd day prior to the event or outreach,
- 50% of the event price for a withdrawal between the 21st day and the start of the event or outreach

If GOSPELTRIBE has already incurred fixed costs at the time of the participant's cancellation, such as the booking of flight tickets, seat reservations with bus companies, etc., the cancellation costs, e.g. for a flight ticket, will be at the withdrawing participant's expense. In such a case, the cancellation costs listed above are based on the event price, less other costs, such as flight cancellation costs, the full amount of which will be retained by GOSPELTRIBE. The organiser reserves the right to prove higher damages in individual cases. If the participant cancels more than 60 days before the start of the event, or if he/she is represented by a suitable substitute with the organiser's consent, only an administrative fee of 50 euros but not more that 10% of the event price will be charged. The above conditions regarding cancellation fees for fixed costs remain unaffected. Participants are advised to take out individual trip cancellation travel insurance.

8. Cancellation by the organiser

If, unless otherwise specified in individual cases, only 50% of the calculated number of participants is reached, the organiser is entitled to cancel the event/outreach up to one week after the given application deadline. The participant will immediately receive a full refund and may not make any further claims for damages.

9. Liability

As the responsible body, the organiser is liable for

- 1. the careful preparation, selection and monitoring of all service providers
- 2. the accuracy of the service description
- 3. the proper provision of all contractually agreed services

in accordance with the local customs of each outreach location.

In the event of any case of negligence by the transport company used to conduct the journey/event, we will solely be liable to the extent and amount specified in the transport company's conditions of carriage.

Any liability for damage caused by delay is hereby excluded.

10. Place of jurisdiction

The place of jurisdiction, to the extent permitted by applicable law, is the registered office of GOSPELTRI-BE e.V.



11. Travel abroad

The participant must take out appropriate health insurance for outreaches and events abroad. The participant is also responsible for ensuring that he/she has received all the vaccinations required for the respective country of travel.

12. Privacy notice

In order to organise and conduct the outreach, we need to store your details from this form in our electronic data processing system. Your details will be treated confidentially and will not be passed on to unrelated third parties.

Your data will be made available to the relevant administrators and employees at GOSPELTRIBE, JMG and THE FOUR, responsible for organising the outreach, and, if applicable, your small group leader. You may revoke your voluntary consent to the storage of your data at any time. You are entitled to request any information we keep about you or to have your data corrected or deleted at any time.
